By the signature of its authorized representative below, Applicant, including its Affiliates (as defined in the Bylaws) agrees to be bound by the terms hereof, as well as the terms and conditions stated in the Articles of Incorporation, Bylaws and IPR Policy (“Organizational Documents”) of the SSI Forum as may apply to the Sponsor/Contributor/Adopter membership classification stated in the Bylaws. The term of membership shall be on a year-to-year basis, expiring on the 365th day from the date of acceptance of this application. The SSI Forum will invoice the then-current renewal fee to Members ninety (90) days prior to the expiration of the pending term and Member’s payment thereof shall constitute a renewal of membership as a Member. Failure to make a timely renewal payment shall be cause for suspension and termination of membership and member benefits.

The undersigned agrees that once accepted, all membership fees are nonrefundable for any reason, including termination of membership. There is no duty to renew any membership and renewal may only be accomplished as set forth above.
